In Africa and Latin America, artists merged indigenous aesthetics with modernist techniques, rejecting both colonial mimicry and Western universalism. Nigerian sculptor El Anatsui, for instance, transforms discarded bottle caps into monumental tapestries—materially and metaphorically weaving global waste into local narratives.
