Geopolitical and Economic Forces Shaping Dietary Choices

Food systems are deeply embedded in geopolitical and economic structures. In the Global North, agricultural subsidies—particularly in the U.S. and EU—favor commodity crops like corn and soy, enabling cheap production of high-fructose corn syrup, processed oils, and animal feed stripped of nutritional value. These inputs fuel ultra-processed foods, which now constitute over 50% of caloric intake in many high-income nations. In contrast, low- and middle-income countries (LMICs) face competing pressures. Rapid urbanization and rising incomes increase demand for processed foods, seen as modern and convenient. Yet limited regulatory capacity, weak food safety standards, and aggressive marketing by multinational corporations—often backed by trade agreements—undermine local food traditions. International commodity markets stabilize food supply but can depress prices of nutrient-rich crops, making fresh produce less accessible.
