This literary association, though never fully embraced by musicologists, seeded the notion that music could be “read” like a poem. Similarly, in South Korea, K-pop’s global success is frequently explained through its “visual poetry”—stylized choreography, conceptual albums, and multilingual lyrics—positioning it as a modern epic that transcends entertainment. Yet this mythologization serves a dual purpose: it legitimizes music as high art in the eyes of global tastemakers while enabling market dominance. In this context, analysis becomes a tool of soft power—elevating artists, justifying pricing, and shaping cultural hierarchies. The danger lies in conflating market narrative with artistic substance. When a song is “about migration,” “resilience,” or “spiritual awakening” not because of its content, but because it serves a market myth, its meaning risks becoming performative.

Expert Perspectives and the Crisis of Methodology
