The European BirdSound project, integrated with raptor ID systems, identifies species from 10-second clips with over 90% accuracy—vital in dense forests or during nocturnal surveys. Drones equipped with thermal and audio sensors now map raptor activity in inaccessible terrain, feeding data into centralized AI systems for automated species counts.
