Simultaneously, grassroots movements—from South Africa’s anti-apartheid struggle to Central American peace campaigns—demonstrated that bottom-up engagement could shift power structures. These experiences seeded the institutionalization of conflict resolution: the United Nations

established its Department of Political and Peacebuilding Affairs in 1992, while NGOs like the Carter Center and International Crisis Group began deploying field-based analysis to preempt crises. Economic imperatives reinforced this shift: the World Bank and IMF increasingly tied development aid to governance reforms, recognizing that fragile states were not only humanitarian concerns but systemic risks to global markets. Digital disinformation campaigns now manipulate public sentiment and delegitimize peace efforts, as seen in Myanmar's Rohingya crisis and Ukraine's information war. Furthermore, the weaponization of aid—where humanitarian assistance becomes a tool of geopolitical leverage—erodes trust and distorts local agency. These threats demand adaptive, resilient systems: agile monitoring, real-time data analytics, and decentralized networks that can withstand disruption. Globally, comparisons reveal divergent models. Norway's emphasis on inclusive dialogue and long-term engagement contrasts with the U.S. focus on rapid stabilization through security partnerships. The African Union's peace architecture, rooted in regional ownership, offers a counterpoint to external intervention. Meanwhile, Latin America's truth and reconciliation commissions—exemplified by South Africa—demonstrate the cultural specificity required in transitional justice. These variations highlight that peace is not a one-size-fits-all formula, but a context-dependent practice requiring humility and learning. Looking ahead, the future of peace studies hinges on three imperatives: first, deepening integration of local knowledge with global expertise, ensuring

that solutions emerge from those most affected. Second, strengthening accountability mechanisms—both within institutions and among funders—to ensure transparency and responsiveness. Third, reimagining peacebuilding as a continuous, anticipatory process rather than a discrete phase—one that embeds conflict sensitivity into development, education, and governance from the outset. Emerging technologies promise both opportunity and risk. Artificial intelligence can enhance early warning systems by analyzing social media, satellite imagery, and economic indicators to detect conflict precursors. Blockchain may secure transparent aid distribution, reducing corruption. Yet, without ethical guardrails, these tools risk surveillance overreach and algorithmic bias.
