Archaeological explorations of the wreck, beginning with Jacques Cousteau in 1985 and continuing through robotic deep-sea missions, have revealed a vessel frozen in time.

The debris field, scattered across 12,500 feet of ocean, offers stark evidence of the ship's violent breakup and final moments. These findings deepen our understanding of structural failure while reinforcing the Titanic's role as a tomb—preserving a moment of human aspiration and fragility.
