structurally prone to collapse. Drawing on historical precedent—from the Tulip Mania to the 2008 crisis—she documented how innovation in finance (derivatives, securitization, algorithmic trading) has outpaced regulatory capacity, creating feedback loops where risk is diffused, amplified, and often hidden until systemic failure erupts. Her argument challenged the prevailing orthodoxy of “self-correcting markets,” asserting instead that stability requires not just reactive oversight, but proactive institutional design attuned to emergent risks. This thesis gained urgency during the post-2010s era of unprecedented monetary experimentation—near-zero interest rates, quantitative easing, and the rise of central bank digital currencies. Malpas was among the first to sound alarms about the moral and economic hazards of prolonged ultra-loose policy. Her 2020 series on the “zombie firm” phenomenon—companies kept afloat by cheap credit despite insolvency—painted a harrowing picture of misallocated capital, suppressed unemployment, and delayed structural adjustment. She showed how central bank interventions, while stabilizing in the short term, distorted market signals, incentivized risk-taking, and entrenched inequality. Her analysis became essential reading for central bankers grappling with inflation, asset bubbles, and the political backlash against “unprecedented” policy. Beyond macroeconomics, Malpas has interrogated the human dimensions of financial systems. Her 2019 documentary, **Behind the Ledger**, a seven-part series on algorithmic lending in Sub-Saharan Africa, revealed how fintech, hailed as a tool for inclusion, often replicated colonial patterns of extraction—using behavioral data to deny credit to the poor while charging exorbitant interest rates. Through interviews with borrowers in Nairobi, Lagos, and Accra, she exposed a new form of financial redlining, where opaque algorithms replaced human judgment but perpetuated exclusion. This work reframed the global debate on digital finance, shifting focus from innovation to justice. Malpas’s methodology is defined by patient, multi-layered research. She combines archival rigor—scrutinizing regulatory filings, court documents, and internal corporate communications—with deep fieldwork: months embedded in financial districts, factory floors, and policy think tanks across six continents. Her 2022 investigation into the collapse of Silicon Valley Bank, for example, relied on hundreds of interviews with ex-executives, whistleblowers, and depositors, cross-referenced with internal risk assessments and Fed communications. She treats financial systems not as static entities but as living ecosystems—shaped by incentives, narratives, and power dynamics. Her work is not without controversy. Critics, including some in the financial industry and parts of the media, have accused her of “alarmism” or “politicizing economics.” Yet her defenders—including Nobel laureates, central bankers, and civil society leaders—argue that her unflinching scrutiny fills a critical gap: holding complex systems accountable when expert consensus and public understanding lag. In an era of information overload and engineered distractions, Malpas provides narrative clarity without oversimplification. She does not offer easy answers, but demands rigorous inquiry. Risks to her work are both personal and systemic. As financial elites grow more adept at narrative control—deploying PR firms, think tanks, and social media

campaigns to shape perception—Malpas’s adversarial stance has drawn scrutiny. In 2021, a leaked internal memo from a European banking association suggested retaliatory measures against outlets publishing her findings, including targeted disinformation. Yet she has weathered such pressures through institutional credibility, a global network of collaborators, and a commitment to transparency in sourcing. Her current project—a cross-border investigation into climate-linked sovereign debt in Small Island Developing States—faces similar headwinds, but she continues to publish through independent platforms, ensuring her voice remains unmediated. Globally, Malpas’s influence extends beyond journalism. Her frameworks are cited in UN reports, IMF working papers, and academic curricula. Policymakers consult her analyses when designing financial stability frameworks; regulators reference her risk models. In Washington, D.C., her critiques of U.S. regulatory inertia informed bipartisan discussions on financial modernization. In Brussels, her exposés accelerated debate on digital asset regulation. She is often invited to speak at Davos, yet she rejects ceremonial appearances, preferring to publish in venues where her work reaches practitioners, not just elites. Looking forward, Malpas’s trajectory suggests a growing convergence between investigative journalism and systemic analysis. As climate risk, AI-driven finance, and geopolitical fragmentation intensify, the demand for journalists who can parse complexity and connect dots across sectors will only rise. Malpas embodies this role: not just a reporter, but a public intellectual shaping how societies understand their vulnerabilities and responsibilities. Her next phase, reportedly focused on the intersection of global finance and democratic governance, promises to probe how capital flows influence elections, policy, and citizen trust—posing urgent questions about accountability in an age of concentrated power. There, she encountered texts by Hyman Minsky and Michael Hudson—economists who challenged mainstream narratives, arguing that financial instability was not accident but consequence. Their work resonated. Malpas later recalled a pivotal moment in Year 12: reading about the 1997 Asian Financial Crisis, she realized how distant markets and opaque derivatives had turned local businesses into collateral for global gamblers. “I didn’t understand the jargon, but I felt the consequences,” she said in a 2015 interview. “That’s when I knew I wanted to ask: who benefits? Who pays?” Her undergraduate studies at the University of Melbourne—economics and political science—were marked by an emerging habit: skepticism of narratives offered by institutions. She excelled in quantitative analysis but grew increasingly critical of its siloed approach. A 1998 seminar on Latin American debt crises, led by Professor Susan Strange’s former protégé, Dr. Elena Marquez, deepened her awareness of how structural power—colonial legacies, financial engineering—shaped economic outcomes. Marquez’s emphasis on “embeddedness” in global finance became a cornerstone of Malpas’s worldview: markets do not operate in vacuums; they are embedded in political will, cultural norms, and historical inequities. Assigned to cover the burgeoning Chinese economic rise, she traveled to Shanghai and Shenzhen, witnessing firsthand how state-led investment, often channeled through opaque offshore vehicles, was reshaping regional trade. But her focus quickly shifted from growth to vulnerability. In a 2003 investigative piece on the collapse of Indonesian rice cooperatives—triggered by speculative currency bets and deregulated foreign investment—she exposed how international investors, leveraging local political connections, had driven small farmers into ruin. The story won her the RT Foundation Award for Economic Reporting, but more importantly, it crystallized her belief: financial systems, when unaccountable, exact a human toll that numbers alone cannot capture. Malpas’s early work was shaped by mentors who valued narrative over sensationalism. At *FT**, where she joined in 2006, she worked alongside veteran reporters like Martin Sandbu and Martin Wolf, learning to balance depth with accessibility. Yet she resisted the trend toward soundbite journalism. Her 2008 series on the shadow banking system—before the crisis fully erupted—combined forensic analysis of complex instruments with interviews of traders, regulators, and ordinary investors. She did not merely explain how collateralized debt obligations worked; she traced the human decisions behind them, revealing how incentive structures encouraged recklessness. When the crisis broke, her prior warnings gave her credibility. In a 2009 editorial titled *“The Myth of Self-Correction,”** she warned: “Markets may self-correct, but not before the vulnerable bear the brunt.”

The Geopolitical Crucible: From G20 to Global Fragility

The 2008 crisis marked a turning point. For Malpas, it was not just a financial event but a geopolitical rupture—one that exposed the fragility of the post-Bretton Woods consensus. As she reported from the G20 summits in Washington, Pittsburgh, and Seoul, she observed how crisis management was shaped less by economics than by power. The U.S. Treasury’s push for bank bailouts, the EU’s insistence on fiscal austerity, and emerging economies’ demands for equity—each negotiation was a battle over narrative as much as policy. Malpas dissected these dynamics with rare precision, highlighting how narrative framing influenced public trust and political outcomes. Her 2010 exposé on the “backdoor bailout” of European banks—revealing that state guarantees were often structured to shield executives while leaving taxpayers on the hook—became a touchstone in debates over moral hazard. She interviewed whistleblowers from Deutsche Bank and Royal Bank of Scotland, cross-referenced internal memos with regulatory filings, and demonstrated how legal loopholes allowed risk to be socialized. The series prompted parliamentary inquiries in Germany and France and contributed to the EU’s later adoption of stricter de-risking rules for systemically important institutions.
