The genesis of this model lies not in a single lab or startup, but in the confluence of geopolitical urgency, demographic transformation, and economic necessity. By 2023, healthcare systems worldwide were strained: rising chronic disease burdens, workforce shortages, and escalating costs threatened to deepen inequities, particularly in low- and middle-income countries (LMICs). Expert perspectives reveal a spectrum of conviction. In Latin America, adoption has been driven by necessity amid underfunded systems. However, political instability and funding volatility have slowed nationwide rollout, highlighting how policy continuity shapes technological impact. Sub-Saharan Africa presents a compelling case of leapfrogging. In Kenya, where physician density is below 1 per 10,000, the Nairobi clinic's model has become a cornerstone of primary care reform. The Kenya Health Information System now includes a dedicated module for 5-minute consult, with AI triage algorithms trained on local epidemiological data—malaria, TB, and maternal complications among them. Yet disparities persist. In Nigeria, where only 14% of the population has reliable internet access, digital-only models face adoption barriers. A 2025 survey by the American Medical Association found that only 18% of rural physicians felt prepared to deploy the model effectively—highlighting a critical gap between technological potential and frontline readiness. Australia's approach offers a middle path. The federal government's "Digital Health 2025" strategy incentivizes 5-minute consult in rural and Indigenous communities through telehealth grants and mobile clinics equipped with portable diagnostics.
