The 2021 Two-Pillar Solution represents the most ambitious effort yet. The agreement, endorsed by over 140 countries, aimed to end the “race to the bottom” by ensuring that multinationals pay a floor tax regardless of jurisdiction. Yet this breakthrough is not without fault lines. The minimum tax applies only to groups earning over €750 million, excluding SMEs and sectors like finance and real estate—areas where profit shifting remains acute. Pillar One’s implementation faces administrative complexity and political resistance, especially from developing nations wary of bureaucratic overload. The U.S. Inflation Reduction Act, with its domestic incentives and carve-outs, risks undermining global coherence.
