Australia leads in lithium and heavy minerals, while Canada excels in nickel and platinum group metals. This geological inequality drives global trade patterns, investment flows, and diplomatic alliances—creating dependencies that redefine 21st-century power structures.

Modern innovations like dry stacking and bioleaching aim to reduce water use and environmental footprint, but adoption remains uneven. The rise of advanced materials has intensified demand for specialty minerals. Graphene, derived from graphite, promises revolutionary applications in electronics and composites. Lithium titanate, used in fast-charging batteries, expands the utility of lithium beyond conventional lithium-ion systems. Meanwhile, perovskite minerals are being explored for next-generation solar cells, potentially disrupting silicon-based photovoltaics. These developments push mining toward higher-value, lower-volume outputs, increasing pressure on supply chains. Refining and metallurgy further transform raw ores into usable metals. Electrolytic refining of copper, for instance, achieves purities exceeding 99.99%, but

requires enormous energy inputs and generates greenhouse gas emissions. Substitution strategies—such as aluminum alloys replacing steel in automotive frames—seek to reduce demand, yet progress is constrained by performance requirements and market inertia. The circular economy offers a counterpoint: recycling metals from end-of-life products. Only about 7–12% of copper and 30% of gold is currently recycled globally, but advancements in hydrometallurgy and urban mining could elevate recovery rates. While mining enables decarbonization technologies, extraction itself is energy-intensive and emissions-heavy. A single ton of lithium carbonate emits up to 15 tons of CO₂ during processing. Deforestation for mines reduces carbon sinks, accelerating global warming. Despite abundant cobalt and copper, GDP per capita remains below \$1,000, and infrastructure is underdeveloped. China's mineral strategy is both ambitious and operational. Through state-led investments, it dominates refining capacity—processing over 60% of global lithium, 90% of rare earths, and 80% of copper. Its Belt and Road Initiative secures access via infrastructure deals, port leases, and joint ventures across Africa, Latin America, and Southeast Asia. This vertical integration gives China pricing power but raises concerns about dependency. The European Union, lacking domestic mineral extraction, pursues strategic autonomy via the Critical Raw Materials Act, aiming to source 40% of needs from within by 2030 and build domestic refining capacity. The EU's focus on recycling, innovation, and partnerships with democratic resource holders reflects a geopolitical shift toward resilience over resource nationalism. In Africa, mineral governance is

evolving. Ghana's recent push for beneficiation—processing gold and bauxite domestically—seeks to capture more value. Nigeria explores lithium potential, while Botswana leverages diamond revenues for education and infrastructure. Yet weak institutions, corruption, and external pressure hinder sustainable management. South America's Andean nations balance resource wealth with environmental limits. Chile, the world's top copper producer, debates nationalization amid public demand for equitable returns. Peru's moratorium on new mining concessions highlights tensions between development and ecological protection. Bolivia's state-led lithium projects aim to avoid past pitfalls but face technical and financial hurdles.
