At the time, NATO's post-Cold War recalibration had exposed critical gaps in human readiness—units trained for conventional warfare struggled with asymmetric threats, asymmetric stress, and the cognitive overload of high-speed decision environments. Collins, leveraging partnerships with UK Special Forces, MI5, and transatlantic behavioral scientists, responded by developing a training framework that transcended physical conditioning.
