The economic implications extend beyond resource extraction. Geophysical data underpins infrastructure planning—from tunneling metro systems in megacities like Tokyo and London to offshore wind farm foundations. The cost of geophysical surveys has plummeted due to digital advances, democratizing access and enabling developing nations to participate in resource management. Yet disparities persist: while high-income countries deploy 3D seismic arrays and

quantum gravimeters, many low-income regions rely on outdated or insufficient methods, exacerbating vulnerability to environmental shocks.

Data integrity and transparency remain persistent challenges. Geophysical models rely on assumptions and incomplete datasets; small errors can propagate into significant miscalculations. The 2010 Deepwater Horizon disaster, partly attributed to misinterpreted subsurface pressure data, exemplifies the consequences. In response, industry and academia have strengthened validation protocols and open data initiatives, but trust remains fragile, especially in politically charged contexts. Environmental geophysics, though critical, is not

immune to misuse. In extractive industries, geophysical surveys are sometimes employed to downplay environmental impacts or expedite permitting—raising ethical questions about scientific independence.
