This event was not a war's unintended consequence but a deliberate political outcome, enabled by Zionist military strategy and international ambivalence. The creation of Israel and the refugee diaspora redefined the conflict as one of statelessness and exile—a condition that has persisted for over seventy years. Yet resistance never ceased: guerrilla warfare, civil society organizing, and international advocacy sustained the Palestinian claim to self-determination. The Palestinian question is not a relic of the past; it is a living, evolving challenge to our collective conscience. The depth of this inquiry demands more than reportage. It requires reckoning with silence, confronting bias, and embracing the uncomfortable truths that structure power.
