Yet the integration of qualitative research into social work practice was neither linear nor uncontested. Geopolitically, the rise of neoliberalism reshaped welfare states, privileging cost-efficiency and measurable outcomes over deep

contextual understanding. In the UK, austerity measures post-2010 drastically reduced funding for longitudinal qualitative studies, pushing many community interventions toward rapid-cycle evaluations. Conversely, in Latin America and parts of Sub-Saharan Africa, grassroots movements and post-conflict reconstruction efforts embraced qualitative research to document human rights abuses and inform transitional justice. In Brazil, for instance, researchers used narrative analysis to map the psychosocial impacts of urban violence in favelas, directly influencing municipal policy and youth outreach programs. These divergent trajectories underscore how macroeconomic forces and political ideologies condition the viability and legitimacy of qualitative inquiry. The methodological evolution of qualitative research in social work reflects a deepening sophistication. Traditional ethnography—once defined by prolonged immersion and thick description—has been augmented by participatory action research (PAR), where service users co-design studies, challenge interpretations, and become agents of change. Narrative inquiry, pioneered by scholars like Arthur Kleinman and later adapted by social workers such as David Kroger, treats personal stories not as data to be analyzed, but as acts of meaning-making, revealing how individuals reconstruct identity amid trauma. Yet this synthesis remains fraught with

tension. Critics argue that mixed-methods designs often regress to positivist hierarchies, where quantitative outputs dominate and qualitative insights are reduced to supplementary validation. In contrast, proponents like Carol Lawson stress that true integration requires epistemic humility—recognizing that narratives resist quantification not out of weakness, but because meaning is irreducible. This epistemic decolonization has empowered marginalized voices, enabling social workers to advocate not just for services, but for systemic transformation rooted in lived truth. Yet the practice is not without risk. The emotional labor of engaging deeply with trauma exposes researchers and practitioners to vicarious injury and secondary trauma. The demand for rapid, publishable findings in a competitive

academic environment can incentivize rushed, superficial analysis. In conflict zones—Syria, Yemen, Ukraine—qualitative researchers face acute dangers: kidnapping, censorship, and the ethical dilemma of representing vulnerable populations without re-traumatizing them. Moreover, power imbalances persist: who controls the narrative? Globally, comparative perspectives illuminate divergent approaches. In contrast, in many East Asian contexts, collectivist values and stigma around mental health constrain open narrative expression, leading researchers to innovate with indirect methods—art-based inquiry, metaphor analysis, and symbolic expression—to access hidden experiences. These variations reveal that qualitative research is not a universal tool, but a culturally embedded practice shaped by local epistemologies and power structures. Ethnographic studies in inner-city neighborhoods, led by pioneers such as Louis Wirth and later Nancy Scheper-Hughes (whose work influenced global health and social work alike), demonstrated how poverty was not merely economic but embodied and relational. By the 1980s, qualitative methods began to institutionalize. The founding of journals like **Qualitative Social Work** and the establishment of academic centers—such as the Centre for Qualitative Social Research at the London School of Economics—signaled a shift. In the U.S., the NASW’s 1988 policy statement on qualitative methods acknowledged the legitimacy of interpretive inquiry, though implementation lagged. Meanwhile, in Latin America, liberation theology and community health movements fused qualitative narrative with activism, producing groundbreaking studies on structural violence. The 1990s saw the rise of narrative therapy and participatory action research (PAR), with figures like Paulo Freire’s pedagogical influence permeating social work education, emphasizing dialogue, co-creation, and the political dimension of storytelling. This period also saw methodological innovation: grounded theory, developed by Glaser and Strauss, offered a systematic approach to theory-building from data, while narrative inquiry formalized the study of life stories as analytical material.

Social workers began embedding ethnographic fieldwork into program evaluation, documenting not just outcomes but the lived experience of intervention. For example, studies of foster care systems increasingly included children's narratives to challenge institutional assumptions about dependency and agency. Yet institutional adoption was uneven. In welfare states with strong public health infrastructures—Scandinavia, the UK—qualitative research gained traction in policy evaluation and service design. In contrast, in the U.S., where clinical practice is often privatized and metrics-driven, qualitative methods remained marginalized outside academic circles. The 2008 financial crisis and subsequent austerity reshaped funding landscapes globally, pressuring social services toward cost-effective, measurable interventions. Qualitative research, seen as resource-intensive and slow, suffered cuts; yet in contexts of crisis, its value reemerged: in Greece's refugee camps, ethnographers documented the erosion of dignity in emergency housing, influencing grassroots advocacy. The 21st century has witnessed a methodological renaissance. Globalization has further complicated this landscape. International organizations like the World Bank and UN agencies increasingly fund “participatory” qualitative studies, yet their agendas often reflect neoliberal imperatives—efficiency, scalability, measurable impact. This creates a paradox: while qualitative methods are promoted as

inclusive, their co-option into development logistics can dilute transformative intent, turning narrative into compliance. In humanitarian settings, rapid ethnographies may inform emergency response, but fail to address root causes of displacement. Economic precarity amplifies these tensions.
