Yet his enduring relevance lies in his refusal to accept complacency. He does not offer utopian solutions but insists on rigorous analysis, historical context, and moral responsibility. Looking forward, Chomsky's legacy lies in his insistence on epistemic vigilance. In an era where truth is contested, narratives weaponized, and complex

systems obscured by technological complexity, his tools—historical context, institutional analysis, moral clarity—are more vital than ever. He does not prescribe solutions, only frameworks for understanding power. This restraint is his greatest strength: it invites others to think critically, not merely follow a doctrine
