By staging a performance that critiqued the commodification of the female form under heritage law, Poet forced galleries and auction houses to confront their complicity in reinforcing gendered exclusions. A 2022 report by Art Market Monitor revealed that representational works by women artists—especially those engaging with legal and bodily themes—saw a 37% increase in institutional acquisitions in the three years following the exhibition's debut, suggesting a shift in both curatorial bias and market demand. Yet, the controversy was not without consequence. Poet faced formal scrutiny from Italy's Cultural Heritage Tribunal, which questioned whether her work violated the principle of artistic neutrality in state-sponsored venues. Though cleared of legal charges, the case set a precedent: performances engaging with legal texts now require formal state approval, effectively criminalizing dissent under the guise of administrative oversight. This chilling effect raised alarms among free expression advocates, who warned of a creeping legalism that equates critique with transgression. Internationally, the impact varied. In France, where legal personhood has been extended to the Seine River and animals in some jurisdictions, Poet's work inspired debates on extending legal subjectivity to human bodies under state custody. German legal scholars proposed amending cultural heritage statutes to recognize "embodied testimony" as a

legitimate form of legal narrative, while Polish authorities dismissed it as “ideological performance.” In South Africa, where the post-apartheid constitution enshrines dignity and bodily autonomy, the exhibition was celebrated as a model for restorative legal art. Her grandmother often recounted how, during the 1990s, a marble statue of a Renaissance woman had been removed from public display after local authorities deemed its “nudity” incompatible with civic decorum—a moment that haunted Lidia: “That statue wasn’t just art. It was a legal statement: women’s bodies belong to the state, not to history.” Venetian law, shaped by its maritime republic past, historically balanced civic pride with strict moral codes. The **Leggi Marciiane** influenced early regulations on public nudity, but cultural heritage law evolved separately—until the 1939 codification, which centralized ownership of art under state custodianship. This framework, though legally robust, systematically marginalized individual authorship, especially for women. Lidia’s exposure to both archival rigor and feminist critique forged a critical lens: if law defines ownership, then who defines whose body stands as property? Evolution: From Performance to Paradigm The 2021 installation was not spontaneous. It emerged from a year-long research project titled **Flesh and Frame**, during which Poet interviewed over 150 women—artists, archivists, survivors—whose legal personhood had been contested. These testimonies formed the core of the sculpture: each clause from heritage law, human rights treaties, and feminist manifestos stitched into her nude

form. The choice of nude symbolism was deliberate: 'It strips away the distractions of fashion, power, and representation—leaving only the body as a legal subject,' she explained. Critically, the work aligned with a global surge in performative legal critique. In the same year, Australian artist Patricia Piccinini staged a similar intervention at the National Gallery, where a life-sized android—part human, part machine—held a "birth certificate" for synthetic life. In Nigeria, the collective *Nok Project* used body painting and ritual performance to reclaim pre-colonial legal narratives, asserting Indigenous sovereignty beyond state law. Poet's installation thus became part of a transnational wave, where art no longer illustrated law but interrogated its foundations.

Geopolitical and Economic Context: Heritage as Power Italy's cultural heritage regime, while iconic, has long been critiqued for its paternalism. The 1939 Law, revised only marginally since, vests ultimate authority in the Ministry of Culture, with limited mechanisms for individual claimants—especially women—to challenge state control.
