The economic implications extend into intellectual property law. Copyright regimes, built on the assumption of individual authorship, struggle to adapt to collaborative, AI-augmented creation. When an AI system generates a novel based on a user’s prompt, who is the author? Is it the programmer, the user, or the collective training data? Courts in the EU and U.S. are only beginning to grapple with these questions. The death of the author, once a theoretical abstraction, now collides with legal infrastructure, demanding new frameworks that recognize distributed agency without collapsing accountability. Expert analysis also reveals a generational shift. Younger creators—especially Gen Z and Alpha—approach authorship differently. For Ama Ata Aidoo, a Ghanaian writer and scholar, the "death of the author" is not a loss, but a liberation—enabling African oral traditions, communal storytelling, and political testimony to reclaim narrative agency from colonial impositions. In her 2020 essay, she writes: 'We never stopped being authors. We were silenced.' This reframing positions authorship as a site of resistance, especially in contexts where state or institutional control seeks to define truth.

Conversely, cognitive psychologists and legal scholars caution against overgeneralization. Dr. Lena Müller, a media cognition expert at Humboldt University, argues that while digital platforms expand participation, they also fragment attention and dilute interpretive authority. 'The human mind seeks coherence,' she explains. 'Anonymous, distributed, hyperconnected narratives risk overwhelming readers, fostering epistemic fatigue and reducing critical engagement.' Her research on algorithmic curation shows that personalized feeds often reinforce existing beliefs, undermining the pluralistic ideal Barthes envisioned. In the legal arena, intellectual property specialists like Professor Rajiv Malhotra of the University of Toronto highlight the urgent need for reform. 'Traditional copyright law assumes a single, identifiable author,' he notes. 'But AI-generated texts, collaborative remixes, and decentralized platforms challenge this model. We need new frameworks that recognize collective ownership, trace contributions, and prevent exploitation—without stifling innovation.' His work on blockchain-based copyright registries proposes a system where every creative input is timestamped and attributed, offering transparency without centralized control. Meanwhile, philosophers of technology such as Kate Crawford caution against techno-utopianism. In her 2022 book *The Atlas of AI*, Crawford warns that attributing authorship to algorithms or systems risks obscuring human responsibility. 'When a recommendation engine composes a story based on user data, who is the author?' she asks. 'The programmer? The data? The algorithm?' This ambiguity, she argues, threatens accountability—especially when AI-generated content spreads misinformation or reinforces bias.
