This selective emphasis reflected both academic limitations and the risk of alienating policymakers invested in stable, Western-aligned governance models. Economically, the production and distribution of Prentice Hall materials were embedded in the late-20th-century expansion of educational publishing as a global industry. Comparative analysis with other global curricula underscores Prentice Hall’s unique position. Unlike Soviet-era history texts, which emphasized class struggle and revolutionary heroism, or Japanese curricula, which often centered national resilience and continuity, the Prentice Hall series attempted a universalist synthesis—balancing regional depth with global comparative frameworks.
