Under Obama, “pivot to Asia” sought to rebalance toward emerging powers, while climate diplomacy and multilateralism signaled renewed engagement. Yet the rise of China—economic, technological, and military—challenged U.S. primacy. Beijing's Belt and Road Initiative, assertive South China Sea claims, and advanced military capabilities forced a recalibration. Trump's “America First” doctrine accelerated deglobalization, questioning alliances, withdrawing from climate accords, and escalating trade wars—policies that weakened institutional cohesion and global trust. Biden's administration has attempted to restore alliances and reassert leadership through the Indo-Pacific Strategy, Build Back Better World, and climate diplomacy. Yet structural constraints persist: congressional gridlock limits long-term strategic investment, while domestic divides over foreign policy—between interventionism and withdrawal—hinder coherence. The war in Ukraine exemplifies this tension: robust military and economic aid to Kyiv underscores commitment to countering Russia, yet broader strategic ambiguity on Taiwan reveals limits in projecting power. China's ascent presents the most profound challenge. Its state-capitalist model, technological

innovation (5G, AI, quantum computing), and global infrastructure reach challenge U.S. economic and ideological leadership. The competition extends beyond trade to critical technologies, semiconductor supply chains, and digital sovereignty. The U.S. response—through CHIPS Act subsidies, export controls, and alliances like the Quad—reflects an industrial policy revival, yet risks escalating decoupling and unintended economic consequences. Russia’s hybrid warfare, election interference, and energy leverage complicate transatlantic unity. The erosion of norms—evident in disinformation campaigns and cyberattacks—undermines democratic resilience. Meanwhile, regional power shifts—India’s rise, Brazil’s environmental role, African agency—demand more nuanced diplomacy than Cold War binaries allow. U.S. alliances remain pivotal but strained. NATO, once a Cold War bulwark, faces internal fractures over burden-sharing and strategic vision. The European Union’s growing autonomy complicates transatlantic coordination. In Asia, U.S. commitments to Japan and South Korea are tested by North Korea’s unpredictability and China’s military expansion. The Quad and AUKUS represent new security architectures, yet integration and trust remain shallow. Economically, U.S. leadership is challenged by rising protectionism, reshoring pressures, and competition from state-driven economies. The U.S.-China tech cold war, with export controls and investment screening, risks bifurcating global markets. Supply chain resilience initiatives aim to mitigate fragility but may deepen fragmentation. Looking ahead, U.S. geopolitical posture hinges on three imperatives: rebuilding alliance cohesion through shared norms and burden-sharing; innovating economic statecraft to balance competition with interdependence; and developing adaptive strategies for hybrid, cyber, and climate security. The Nixon-era opening to China proved transformative—but the current era demands deeper recalibration, rooted in democratic values, technological foresight, and global partnership. The U.S. cannot lead alone, but it must shape a rules-based order resilient enough to withstand 21st-century turbulence.
