In the United States, the CDC reported that over 60% of adults had at least one chronic condition, many tied to diet-induced inflammation. This context created fertile ground for alternative frameworks like Asa's, which positioned food not as a passive commodity but as a therapeutic agent. Simultaneously, the global nutraceutical and functional food market—valued at \$197 billion in 2022—was undergoing transformation. Multinational corporations, facing regulatory pressure on processed foods, pivoted toward “scientifically backed” supplements. The anti-inflammatory diet capitalized on this shift, leveraging clinical terminology to bridge the credibility gap often missing in wellness marketing. Yet its funding model diverged from typical industry-backed products: Asa's initiative initially relied on public grants, patient co-pays, and limited partnerships with academic institutions, eschewing direct ties to major food manufacturers. This independence insulated it from immediate commercial distortion but constrained scalability.

Geopolitically, the diet's traction varied dramatically across regions. In Scandinavia and parts of East Asia, where traditional diets already emphasized fermented foods, omega-3s, and seasonal produce, adoption was rapid and culturally resonant. In contrast, in regions dominated by monoculture agriculture—especially corn and soy in parts of Latin America and the American Midwest—promotion emphasized homegrown, plant-based staples to align with local food sovereignty movements. Dr. Amara Nkosi, director of the African Center for Food Systems Research, highlights equity concerns: “The diet’s scientific foundations are sound, but its implementation assumes access to fresh produce, education, and time—luxuries not universal.
