But its design incorporated risky compromises: graphite moderators enabled control via control rods, yet the rods initially *increased* reactivity during shutdowns, a phenomenon poorly communicated and misunderstood. When inconsistencies arose during the safety test—stalled pumps, erratic instrumentation—supervisors hesitated to halt the procedure, fearing reprimand or exposure of incompetence.

The lack of an emergency core cooling system (ECCS) was a critical oversight.
