atmospheres—a process vulnerable to contamination and thermal gradients. Even minute defects or impurities disrupt the CuO_2 planes, the primary sites of pairing, collapsing the superconducting transition. Alloy engineering further complicates matters. Meanwhile, the European Union's Horizon Europe program funds collaborative projects like SUPERCONDUCTOR-X, aiming to bridge fundamental research and industrial deployment. These national trajectories

reflect a broader contest: superconductivity as a strategic enabler of energy sovereignty, defense technology (e.g., superconducting magnets for particle accelerators and fusion reactors), and next-generation computing.

Moreover, mechanical stress undermines performance. Superconductors are inherently brittle; thermal contraction during cooling induces microcracks. In power cables, cyclic thermal loading from load variations accelerates fatigue. Engineers combat this with composite wraps and stress-relieving architectures, but long-term reliability under real-world strain remains unproven at scale. In magnetic levitation (maglev) systems, such as China's Shanghai Transrapid or Japan's L0 Series, superconducting magnets enable frictionless transit at 600 km/h, yet require continuous cryogenic support and precision alignment, limiting deployment to high-investment corridors.
