and aggression. Yet, its creation was as much a diplomatic compromise as a legal breakthrough. The United States, China, India, and Russia never ratified the treaty, fearing jurisdictional overreach. The U.S. even deployed executive orders to sanction ICC officials investigating American personnel in Afghanistan—a direct assault on the Court’s legitimacy. This resistance revealed a fundamental tension: while the legal framework for universal accountability existed, enforcement remained hostage to power asymmetries. The ICC’s early cases laid bare both possibility and limitation.
