When Netflix acquired global streaming rights in 2022, it sparked debate over whether digital distribution diluted the theatrical experience or expanded access to a global audience. The decision ultimately affirmed a new paradigm: musicals as streaming originals, capable of reaching millions who might never see a live show.
