Emerging economies now navigate this divide with dual strategies: some, like India and Brazil, pursue self-sufficiency in polar solvent manufacturing to reduce import dependency, while others—Kenya, Indonesia—export raw nonpolar feedstocks to global markets, capitalizing on demand from Asian and European industries. The result is a fragmented but dynamic landscape, where geopolitical leverage shifts with policy, innovation, and environmental regulation.
