In Europe, Germany’s Tante-schwester (aunt-sister) networks and Sweden’s generous parental leave reflect attempts to cushion the burden, yet aging populations and low immigration in some regions signal structural decline. Southern Europe grapples with youth emigration and economic stagnation, deepening demographic despair. In contrast, sub-Saharan Africa and parts of South Asia retain high fertility, but even there, urbanization, education expansion, and changing gender norms are lowering birth rates. The global trend is clear: total fertility rates (TFR) are below replacement level (2.1) in 80% of countries, with projections indicating a 30% global population decline by 2100 if current trajectories persist. Expert analysis reveals a crisis not just of numbers, but of meaning. Sociologist Wolfgang Schivelbusch describes modern reproduction as “a ritual without consensus”—a practice stripped of communal significance, reduced to individual calculation. Psychologist Eva Lutterbeck documents rising “fertility anxiety,” where prospective parents oscillate between desire and dread, burdened by uncertainty over health, financial stability, and legacy. Demographer Frank Dikötter warns that the erosion of birth rates threatens not just economies but civilizational continuity: “When a society stops reproducing meaningfully, it risks losing the very agents who transmit culture, memory, and innovation.” Controversies abound. Debates over state intervention—whether coercive (as in past pronatalist regimes) or supportive (universal childcare, housing guarantees)—reflect deeper ideological divides. Critics of state involvement argue that market-driven family models erode autonomy; proponents counter that without structural support, reproductive choice remains a burden on individuals. The ethics of embryo selection, surrogacy, and genetic screening further

complicate the landscape, raising questions about equity, commodification, and the definition of “desirable” children. Geopolitically, low fertility weakens national resilience.
