These principles were not merely theoretical—they were operationalized through manual techniques, including joint articulation, muscle stretching, and myofascial release, later refined into what became known as osteopathic manipulative treatment (OMT). Unlike the invasive surgeries dominant in allopathic medicine, Still's method emphasized gentle, non-invasive manipulation, positioning the practitioner as a facilitator rather than an aggressor. Yet Still's vision was not born in isolation. The late 19th-century American medical landscape was a patchwork of competing schools—homeopathy, eclectic medicine, chiropractic (founded just a few years earlier in 1895), and of course, allopathy. The osteopathic movement arrived amid rising nativism and skepticism toward foreign medical systems, particularly those originating in Europe. Still was deeply critical of what he viewed as the dogmatism and commercialism of established medical institutions, which often dismissed patient-centered care as unscientific. His resistance extended beyond theory: he founded the American School of Osteopathy (now the A.T. Still University) in 1892 in Kirksville, Missouri—not as a clinic, but as a radical experiment in medical education, emphasizing clinical observation, hands-on training, and interdisciplinary learning long before such concepts became widespread. Geopolitically,

the emergence of osteopathy coincided with America's westward expansion and the rise of a new class of rural and frontier physicians who lacked access to established medical centers. In this context, osteopathy filled a critical gap—providing care where allopathic physicians were scarce and patients distrusted urban medical elites. The movement gained traction in the Midwest and South, regions defined by agrarian life, manual labor, and high rates of trauma and occupational injury—conditions where manual therapy had immediate, tangible benefits. By the early 20th century, osteopathic colleges proliferated across the U.S., supported by a growing network of practitioners who saw their work as both a scientific and humanitarian enterprise. Still's legacy, however, was not without contradiction. This global diffusion reflected deeper geopolitical and cultural dynamics. In nations with centralized healthcare systems, osteopathy often entered through niche integration—used as complementary therapy rather than primary care. In decentralized systems like the U.S., its growth was driven by market forces and patient choice. In collectivist medical cultures, the individualistic, patient-centered ethos of osteopathy resonated differently, sometimes clashing with communal health priorities. Ongoing clinical trials investigating OMT's efficacy in conditions like fibromyalgia and post-traumatic stress disorder may unlock broader insurance coverage. Regulatory harmonization—particularly in cross-border practice and telehealth—will expand market access. Finally, digital health
