The formalization of passport issuance emerged post-World War II, driven by Australia's shift from a British dominion toward a sovereign actor in global affairs. The *Passports Act 1955* marked a foundational moment: it centralized authority under the Department of External Affairs (now Foreign Affairs), establishing a national framework aligned with emerging international norms. This shift mirrored broader geopolitical realignments—Australia's post-war immigration boom, sealed by the 1945–1970 migration program, created demand for standardized travel documents, reinforcing the passport as a tool of statecraft. By the 1970s, the *Passports Act 1974* redefined the legal architecture, introducing rigorous security vetting and embedding human rights considerations in line with evolving international standards. The Act reflected growing global awareness of identity fraud and terrorism risks, necessitating biometric integration and centralized database management. The 21st century introduced further complexity. The *Passports (Security and Management) Act 2015* responded to heightened global threats, tightening requirements for identity verification, enhancing anti-fraud protocols, and expanding the capacity for digital issuance. Dr. Elise Moreau, a migration policy scholar at the Australian National University, notes: “The system prioritizes risk mitigation, but in doing so, it may inadvertently exclude those with imperfect records—refugees with incomplete documentation, Indigenous Australians navigating historical disenfranchisement, or new migrants unfamiliar with bureaucratic idioms.” This tension between security and inclusion defines contemporary debates. However, such innovations raise ethical questions. The use of facial recognition for identity proof, while efficient, risks algorithmic bias—particularly against

non-white applicants, whose facial features may not align with training datasets. Moreover, the shift to digital-only submission risks excluding elderly or low-income populations without reliable internet access, exacerbating digital divides. Controversies persist around dual citizenship and refugee applications.
