Her fieldwork in Senegal reveals that oral affirmations and communal witnessing still hold weight in rural communities, challenging the universality of formal jurats. Risks are manifold. A 2023 study by the MIT Media Lab demonstrated that deepfake handwriting detection systems, while improving, struggle with subtle variations in stroke dynamics and pressure—features that distinguish authentic samples. In high-stakes cases, such as asylum applications or property transfers, a

forged sample can lead to wrongful deportation or violent land disputes. Moreover, the centralization of document data introduces systemic vulnerabilities. In 2021, a ransomware attack on a major European notary association exposed over 50,000 jurats and writing samples, triggering identity crises across member states. Comparative analysis reveals divergent approaches to authenticity. This framework supports cross-border recognition, though implementation varies widely among member states. In contrast, the United States operates under a patchwork of state-level laws, with remote notarization permitted only in a subset of jurisdictions and strictly regulated. In Asia, Japan’s *shomeisho* system combines traditional notarization with biometric verification, enhancing reliability but raising privacy concerns. China’s digital identity platform, *My Identity*, integrates AI-driven handwriting analysis with national ID data, enabling near-instant verification but operating within a surveillance-heavy governance model. These variations reflect broader tensions between security, privacy, and state control. The Global Identity Alliance, launched in 2020, seeks to harmonize standards. Its 2024 framework proposes a layered verification protocol: a cryptographic jurat issued by a certified notary, accompanied by a multimodal writing sample validated through AI and liveness detection. This model aims to balance authenticity with adaptability across jurisdictions. Looking ahead, the jurat and writing sample are poised for a transformation driven by decentralization, artificial intelligence, and ethical governance. Blockchain-based notarial registries could provide immutable records of jurisdictional affirmations, ensuring integrity across borders. Smart contracts may automate jurat execution, linking document authenticity to real-time

verification of signer identity and intent. Yet technology alone cannot solve systemic flaws. The future lies in hybrid models that blend digital rigor with human oversight. Forensic teams must evolve into multidisciplinary units—combining handwriting experts, AI specialists, and ethicists—to validate authenticity in an era of synthetic media. Regulatory frameworks must prioritize transparency, requiring clear documentation of verification methods and avenues for appeal. Economically, the demand for trusted identity will only grow.
