Their independence is eroded not by individual malfeasance, but by systemic ambiguity."

The repercussions extended beyond AEF. Competitors recalibrated audit strategies, investing in AI-driven anomaly detection and blockchain-based transaction tracing to pre-empt similar disputes. Investors grew wary of

Mexican financial statements, particularly in sectors with opaque ownership—prompting calls for mandatory third-party audits of SOEs and enhanced disclosure mandates. Globally, Sánchez Curiel’s case echoed parallels in other emerging markets. In Brazil, the 2016–2017 *Lava Jato* scandal revealed similar patterns of audit complicity in large-scale fraud, leading to sweeping reforms in the Brazilian Auditing Council (CBF).
