Meanwhile, in South Korea, the success of films like *The Handmaiden* (2016) and *Decision to Leave* (2022)—which blend eroticism with psychological complexity—demonstrates how transgressive storytelling can be leveraged to project cultural sophistication and global relevance, even amid conservative social undercurrents. The role of parents in this ecosystem has undergone a profound transformation. Once passive recipients of state-mandated guidelines, modern parents now inhabit a digital information landscape where content is dissected in real time across parenting forums, YouTube reviews, and TikTok critiques. Its banning in several UK schools and scrutiny by the

British Board of Film Classification signaled a shift—transgression was no longer just cinematic but cultural, demanding institutional response. The digital revolution of the 2010s accelerated this evolution. Streaming platforms dismantled geographic and scheduling barriers, enabling films like **Follow** (2017) or **Firecrackers** (2022) to reach global audiences instantly.
