The economic context further shaped the project's urgency. The 2010s had seen the collapse of traditional print revenue models, leading to a contraction in long-form journalism funding. Yet the GEI team observed a parallel trend: a growing appetite among readers—particularly younger, globally connected audiences—for substantive, trustworthy reporting. Second, they embraced narrative complexity, resisting oversimplification even when dealing with traumatic or controversial subjects. Third, they prioritized ethical engagement: informed consent, transparent sourcing, and accountability to the communities represented. Yet these works also exposed systemic gaps. Many were produced outside institutional support structures—independent journalists operating with minimal resources, often under threat of censorship or violence. Others were rejected by mainstream outlets that privileged speed and sensationalism over depth. The GEI concluded that excellence could not be measured by universal metrics alone; it required a framework sensitive to geography, power, and lived experience.
