In 2023, **The Accountability Project** documented over 120 cases of digital harassment targeting whistleblowers linked to Liverpool’s investigations. Meanwhile, legal frameworks in key jurisdictions remain uneven—offshore centers like the British Virgin Islands and Seychelles maintain lax disclosure laws, exploited by the world’s wealthiest. Liverpool’s response is strategic.
