These expert engagements elevated the script from a theatrical artifact to a philosophical and political catalyst. It became a touchstone in debates about autonomy, power, and meaning in the 21st century.

The revival was not without friction. Traditionalists decried the film as a sacrilege, arguing that Kierkegaard’s existential depth was reduced to aesthetic spectacle. In conservative media circles, the project was labeled “nihilistic propaganda,” with some commentators warning that its emphasis on futility undermined civic responsibility. In Hungary and Poland, where state-backed cultural institutions dominate, screenings were quietly canceled, framed as “Western decadence.” More insidiously, the script’s ambiguity invited instrumentalization.
