Though it launched **Foreign Affairs**'s website and expanding video content, its core audience remains senior policymakers, university faculty, and diplomatic staff. The magazine's 2019 decision to restrict print circulation and pivot fully digital underscored a strategic bet on accessibility and speed—key advantages in an era where real-time analysis can shift diplomatic momentum. Yet, this transition also raised questions about diminishing influence in an age where influence is increasingly decentralized across social media and niche digital platforms. Both publications face disruption from newer entrants: **The Bulletin**, **The Grayzone**, and **Strategic Culture** cater to niche audiences with rapid, often contrarian takes; while platforms like **Foreign Policy**'s own “The Strategist” newsletter replicate magazine content with algorithmic precision. Critics argue that its proximity to power can lead to groupthink, especially on urgent military interventions or intelligence matters. Yet supporters praise its ability to anticipate nonlinear risks—cyber warfare, hybrid threats—through lived experience. *Foreign Affairs*, with its academic pedigree, often hosts dissidents and contrarians. Its contributors range from Nobel laureates like Amartya Sen to rising voices on decolonizing global governance. Risks, Vulnerabilities, and the Future of Authority

Both publications face existential risks in an era of disinformation, declining trust in institutions, and algorithmic media fragmentation. *Foreign Policy*'s rapid digital expansion exposes it to click-driven pressures, potentially compromising depth. Its reliance on rapid response can blur lines between analysis and commentary, inviting accusations of advocacy masquerading as insight. Moreover, its U.S. policy establishment focus risks alienating audiences in regions skeptical of American hegemony. *Foreign Affairs* confronts a different dilemma: how to remain relevant when its traditional readership ages and digital-native audiences consume information in micro-bursts.
