For over a century, these documents—scattered across private vaults, digital archives, and underground networks—have served as barometers of market sentiment, intelligence tools for state actors, and lucrative enterprises for elite analysts. Yet their true significance extends far beyond mere odds or snapshots of future yields. They encapsulate the evolving nature of risk, the globalization of finance, and the enduring tension between transparency and opacity in markets.
