The Swati, under leaders like Sobhuza I, initially allied with Boers to counter Xhosa expansion but later found their autonomy eroded by British imperial oversight. Compounding displacement was the colonial labor system, which reconfigured tribal economies. Beginning in the mid-19th century, migrant labor became central to the South African economy. Men from rural Xhosa, Zulu, and Sotho communities were recruited—often under coercive conditions—to work in gold mines, diamond fields, and maize plantations.
