The comics became a coded battleground: each mutant—Beast with his bearded intellect, Wolverine with his fading savagery, Storm wielding elemental power—embodied a different facet of marginalized identity. By the 1980s, under the stewardship of Chris Claremont and John Buscetta, the X-Men evolved into a nuanced exploration of trauma, ethics, and resilience, their narratives interwoven with Cold War paranoia (e.g., the Shadow King arc) and critiques of militarism (e.g., the “Dark Phoenix Saga”). By contrast, The Avengers—though formally introduced as a team in 1963 with the “Avengers #1”—did not crystallize as a cohesive cultural force until the 2012

Marvel Cinematic Universe (MCU) launch. The Avengers, a superteam of disparate heroes—Iron Man, Captain America, Thor, Hulk, Black Widow, Hawkeye—were not born from social allegory but from narrative convenience and corporate synergy. Their power lay in unity: a fractured world under siege required a coalition of strengths. This vision, articulated through Kevin Feige’s cinematic architecture, reflected a post-9/11 worldview: strength through collaboration, diversity as strategic advantage, and heroism as collective, not individual. The Avengers were less about identity politics than about operational synergy—a mirror of global counterterrorism alliances, tech-driven efficiency, and the mythos of American exceptionalism refracted through Hollywood’s industrial lens.
