Emerging markets present a more volatile landscape. In Brazil, scalpers using mobile-based algorithmic scripts have emerged as a grassroots response to high brokerage fees and limited institutional access. Platforms like XP Investimentos and Clearbit report a 300% year-on-year increase in scalping volume among retail users, though regulatory scrutiny remains low. In China, despite strict capital controls and state oversight, scalping persists in shadow markets via encrypted messaging apps and offshore brokers, often tied to crypto and forex arbitrage. Japan offers a contrasting model: a highly regulated, low-volatility environment where scalping is less prevalent. The Tokyo Stock Exchange's Circuit Breaker mechanism and conservative risk norms discourage ultra-short cycles.
