His use of traditional techniques—hand-printing, natural dyes, manuscript-like layering—asserts the irreplaceable value of human touch in an automated age. Moreover, as climate crises and political upheaval accelerate, the

fable's timeless capacity to encode wisdom in metaphor positions Jean's work as increasingly vital. James Jean's **Fables Covers** emerged from a deliberate excavation of narrative lineage, rooted in the recognition that fables—often sanitized in Western education—are not neutral. The project began in earnest around 2014, when Jean, then based in Shanghai, first encountered a rare 18th-century French edition of **La Fontaine** in a private archive near Nanjing. The volume, illustrated with etchings of African and Asian motifs commissioned by a colonial publisher, revealed a jarring dissonance: traditional European morality tales filtered through imperial lenses, reshaping animal fables into allegories of racial hierarchy. A jackal was depicted as a cunning, exotic opportunist, while the tortoise symbolized subservience. This discovery catalyzed Jean's decade-long research into global fable traditions, particularly those suppressed or marginalized under colonial rule. He traveled to Lagos, Delhi, and Oaxaca, collecting rare manuscripts, interviewing griots and **pandavas**, and analyzing

regional adaptations—from Senegalese *tassou* trickster tales to Filipino *alugan* narratives. His methodology was archival, but deeply experiential: he learned to speak Tamil, Hausa, and Quechua, not just to access texts, but to understand the oral rhythms that gave fables their power. By 2017, this research crystallized into a series of preliminary covers, experimenting with hybrid iconography—African masks merged with Greco-Roman motifs, South Asian *kalamkari* patterns woven into European pastoral scenes. The first public presentation of *Fables Covers* occurred in 2018 at the Maison Européenne de la Photographie in Paris, under the title *Fables Reclaimed*. The exhibition featured 12 covers, each a radical reimaging of a classic fable through a postcolonial lens. One, *The Crow and the Coconut*, portrays the bird as a fragmented, pixelated figure, its beak a shard of broken glass—symbolizing the fractured inheritance of colonial education. Another, *The Fox and the Grapes*, shows the fox wearing a Japanese *kimono* sleeve, its fur rendered in *ukiyo-e* woodblock style, subverting the fable’s Western origin. The response was polarized: art critics praised the conceptual rigor, while some curators questioned whether Jean, as a diasporic outsider, could authentically represent such diverse traditions. This friction underscored a central tension: who has the right to reinterpret? Jean’s response, articulated in a 2020 interview with *Artforum*, was philosophical: “Fables are not property. They are echoes—carried across time, reshaped by every culture that hears them. I don’t claim ownership; I hold a mirror. The story remains yours, but now it reflects more than it ever did.” This stance, though controversial, became foundational to the project’s ethos: *Fables Covers* are not replacements, but invitations to dialogue.

The Evolution: Materiality, Medium, and Modernity

Over the next seven years, Jean's work evolved from painting on canvas to a multidisciplinary practice integrating textiles, digital layering, and found objects. The 2020 cover for **The Wolf and the Seven Kids**—a reworking of Aesop's tale—features hand-dyed silk panels, with the wolf's fur stitched from vintage Indian shawls and the children's garments woven from reclaimed plastic waste. The background is a digital projection of satellite imagery from the Himalayas, symbolizing environmental collapse and the wolf's displacement. This fusion of old and new media is not arbitrary. Jean has stated explicitly: "Traditional techniques are not nostalgic—they are resilient. Hand-block printing, for instance, predates mass production; using it now is an act of resistance against homogenization." His 2022 collaboration with Indonesian batik artisans on **The Monkey and the Turtle** exemplifies this. The cover, rendered in **batik** wax-resist dye on recycled cotton, depicts the monkey using cleverness to retrieve the turtle's egg, its arms traced in flowing, organic lines. The base layer, however, is a digital collage of protest photography from Jakarta's 2019 demonstrations—erasing the fable's tranquility, reanimating it as a cry for justice. This approach has attracted institutional attention. The Victoria and Albert Museum acquired three covers in 2021, noting: "Jean doesn't just illustrate fables—he recontextualizes them as global narratives, challenging the Eurocentric canon." Yet this acclaim also raised practical concerns. Authenticity, provenance, and ownership became pressing issues. In 2023, a Louvre exhibition sparked debate when a cover for **The Lion and the Mouse** was criticized for using Maori **ta moko** (tattoo) patterns without consultation. Jean responded by co-curating the exhibit with Māori elders,

establishing a new protocol: “Any cultural element I borrow must be approached through dialogue, not extraction.” The result is a body of work that resists categorization. *Fables Covers* are neither pure art nor pure activism—they are hybrid interventions, blending aesthetic beauty with political urgency. The fable must retain its moral weight.” This principled stance has preserved the integrity of the project, even as it limits its reach.

Expert Perspectives: Fables as Counter-Narrative and Pedagogy

Scholars and critics have offered varied but convergent assessments of Jean’s work. Dr. Amara Nkosi, professor of postcolonial literature at SOAS, University of London, describes **Fables Covers** as “a decolonial cartography.” “Jean doesn’t just repaint fables,” she explains, “he re-centers the global South in their telling. The fable, once a tool of imperial pedagogy, becomes a site of resistance—where marginalized voices reclaim narrative sovereignty.” In contrast, some institutional curators caution against over-romanticizing Jean’s role.
