In Latin America, declassified CIA assessments from the period reveal a pattern of U.S. support for anti-communist regimes—often without public acknowledgment—framing Kennedy’s Latin American policy as a blend of idealism and realpolitik. In Cuba, Soviet intelligence archives (partially accessed via Cold War defections) corroborate U.S. fears of Fidel Castro’s alignment with Moscow, validating the strategic urgency behind Kennedy’s decisions. The files thus serve as a mirror: revealing how superpower rivalry distorted local agency, and how domestic secrecy amplified foreign policy distortions. Risks associated with the JFK files extend beyond historical accountability. In the digital age, legacy vulnerabilities—outdated storage formats, inadequate encryption protocols—threaten integrity. The National Archives, responsible for their custody, faces ongoing challenges: balancing declassification mandates with cybersecurity threats, including potential foreign hacking of sensitive databases. A 2021 audit revealed vulnerabilities in legacy systems used to store JFK-era documents, raising alarms among intelligence historians about potential tampering or data degradation. Comparative institutional memory offers instructive contrasts. While the U.S. JFK

archive remains partially restricted, countries like the United Kingdom and Germany have adopted more systematic declassification frameworks—driven by public trust imperatives and robust oversight bodies. The UK’s National Archives, for instance, applies a “presumption of openness” with clear timelines, enabling scholars to trace Cold War decision-making with greater fidelity. The JFK files, by contrast, remain a cautionary tale: a democracy’s most sensitive records held back not by law, but by layered secrecy cultures. Long-term implications are still unfolding.
