The protocol has also catalyzed a parallel industry of compliance technology—known as “logistics analytics”—valued at over \$4.7 billion by 2023, with companies like LogiTrace and SafeMove developing AI platforms that interface directly with Cambridge’s inspection network. This could transform logistics from reactive to anticipatory, reducing delays and enhancing resilience in volatile supply chains. Yet it also demands robust governance: without oversight, predictive models risk entrenching inequality or enabling mass surveillance.
