In Germany, his critiques of over-reliance on foreign supply chains have contributed to the “de-risking” agenda—rebalancing trade toward trusted partners without abandoning openness. Yet Groubert remains acutely aware of the risks. He cautions against the dangers of economic nationalism devolving into protectionism, which can trigger retaliatory measures and fragment global markets.
