The National Council of Educational Measurement (NCEM), later part of the GED Testing Service (GTS), codified learning objectives emphasizing critical thinking, source analysis, and contextual understanding—departing from rote memorization. This shift aligned with broader educational reforms emphasizing applied knowledge, yet retained the core civic mission: students were not just learning facts, but how to engage with civic systems.

Evolution: From Print to Digital, and the Rise of ‘Global’ Social Studies

This trend reflects a broader tension: the GED

However, there are defenders who see pragmatic value in the GED model. Dr. Emilia Torres, a comparative education

expert at the University of Cape Town, notes that in post-conflict and low-resource settings, the GED's social studies framework provides a cognitively structured entry point into civic education—offering a scaffold upon which to build critical consciousness. When paired with community-based facilitation, she argues, it can cultivate informed, engaged citizens, particularly where formal schooling remains fragmented. Thus, expert discourse centers on a fundamental question: Can a standardized, test-driven social studies curriculum fulfill its democratic promise in diverse, unequal societies?
