Dr. Elena Marquez, a critical data ethicist at the Institute for Global Bioinformatics Governance, notes: “Holt’s classification system is not neutral. For instance, aggregated, de-identified clinical trial data from high-security projects is offered to pharmaceutical partners via secure portals, generating non-dilutive revenue streams. Simultaneously, restricted access ensures that proprietary algorithms and novel therapeutic targets remain protected, preserving market exclusivity. This model mirrors the broader industry shift: from product-centric firms to platform-based knowledge enterprises. Holt’s classification system thus functions as a dual engine—driving innovation internally while enabling external commercialization through controlled data access. Yet this power concentrates risk. Cybersecurity experts warn that the very granularity of classification creates attack surfaces.
