Only 43% of secondary schools in Nigeria have access to computer labs, according to the 2023 National Education Management Information System (NEMIS), severely limiting hands-on engagement with computational tools central to SS2's modeling and simulation components. Where technology is available, connectivity is inconsistent, rendering digital learning platforms and cloud-based resources unreliable. This digital divide is not merely logistical; it reinforces existing inequities.

Urban schools in Lagos or Abuja, often affiliated with private or elite public institutions, deploy interactive whiteboards, AI tutors, and live virtual labs, creating a stark contrast with rural centers where teachers rely on chalkboards and paper-based exercises. Teacher capacity further complicates implementation. SS2 demands educators fluent not only in content but in facilitation—guiding inquiry, managing open-ended tasks, and integrating technology. Yet, the Nigerian teaching force faces acute shortages: over 15% of teachers are untrained in modern pedagogical methods, and 60% report less than 20 hours of professional development annually, far below international benchmarks. The Federal Ministry of Education’s 2022 Teacher Development Strategy outlines expanded training, but rollout has been slow, constrained by funding and bureaucratic inertia. In rural areas, veteran teachers—often overburdened with large class sizes—struggle to adopt SS2’s project-based approach. The result is a bifurcated system: in well-resourced settings, students engage in authentic problem-solving; in under-resourced ones, instruction remains procedural, rote, and disconnected from real-world relevance. Socio-economic factors deepen these disparities. Families in low-income communities frequently prioritize immediate survival over long-term educational investment. Dropout rates in secondary schools reach 35% nationally, with girls, rural youth, and those in informal settlements

disproportionately affected. For students navigating daily challenges—food insecurity, limited access to sanitation, or family caregiving— mathematics often appears abstract and irrelevant. SS2’s emphasis on contextualized learning attempts to counter this by embedding problems in familiar settings—local markets, farming economics, community health—but without complementary support (after-school tutoring, mentorship, or parental engagement), many students remain disengaged. Equity concerns are further magnified by the curriculum’s decentralized governance. Nigeria’s federal structure grants states significant autonomy, leading to fragmented implementation. While some states—Lagos, Ogun, and Oyo—have piloted robust SS2 models with dedicated funding and monitoring, others lag due to political instability, budget shortfalls, or bureaucratic inefficiency. This unevenness risks creating a national education system where mathematical opportunity is determined more by geography than merit or need. The assessment regime compounds these inequities. National examinations, still heavily weighted toward memorization and standardized problem sets, fail to reward the critical thinking and applied reasoning SS2 aims to cultivate. Teachers report that exam pressure incentivizes “teaching to the test,” undermining efforts to foster deeper understanding. Recent pilot programs introducing performance-based assessments—such as portfolio submissions, oral defenses, and project

evaluations—show promise but require systemic buy-in, standardized rubrics, and training to avoid subjectivity. Yet, amidst these challenges, pockets of innovation demonstrate the curriculum’s potential. In the Eko Innovation Hub, a public-private initiative in Lagos, schools use Raspberry Pi kits and Python-based simulations to teach probability and optimization, transforming abstract concepts into tangible projects. Similarly, the University of Benin’s “Mathematics for Development” outreach program trains teachers in community-based modeling, linking student learning to local infrastructure planning. These models, though localized, suggest pathways for scaling SS2’s vision through grassroots adaptation and stakeholder collaboration. Long-term, SS2’s success hinges on systemic reforms that transcend curriculum design. Investment in digital infrastructure—expanding broadband access, equipping schools with tablets and offline learning platforms—is nonnegotiable. Expanded teacher training must be sustained, with incentives for continuous professional development and mentorship networks. Crucially, equity-focused policies—scholarships, school feeding programs, and targeted outreach—must address the socio-economic barriers that limit access. Looking ahead, the SS2 framework offers a critical test case for how developing nations can align education with 21st-century realities. Its legacy will not be defined by initial rollout but by its

Professor Ngozi Nwosu, a mathematical education specialist at the University of Ibadan, offers a more critical lens. She praises SS2’s interdisciplinary focus but warns against underestimating the pedagogical shift required. “Shifting from procedural fluency to conceptual understanding demands a cultural change in teaching. Many educators are still trained in the old paradigm—by reforming the curriculum alone, we cannot fix decades of entrenched practice. We need sustained professional learning communities and mentorship support.” Nwosu advocates for embedding SS2 within broader educational reforms, including early childhood math exposure and community-based learning initiatives.
