From Grassroots Philanthropy to Global Financial Instrument

In the Middle East, Islamic charitable endowments (waqf) have reinterpreted pledge traditions through fatwa-compliant digital contracts, aligning ancient practices with modern fiduciary standards. Expert perspectives reflect this complexity. Dr. Ananya Roy, urban scholar and philanthropy critic, argues: “The pledge card is a double-edged sword.
