The economic infrastructure sustaining this phenomenon is vast and often invisible. The global luxury footwear market, valued at \$60 billion in 2023, increasingly targets business women with “professional” collections—think Gucci’s “Cushion” heels or Prada’s ergonomic stilettos—designed to balance aesthetic authority with wearability. Brands invest heavily in material innovation: memory foam insoles, lightweight composites, anti-fatigue soles. Yet, accessibility remains uneven.
