This absence was not incidental; it was a calculated assertion of colonial control, reinforcing the exclusion of Indians from their own governance. The Commission arrived in 1927,

and what followed was a sustained campaign of opposition, with Ambedkar emerging as one of its most incisive critics. Ambedkar's critique was not born of mere political opposition but of a profound understanding of colonial epistemology. The Commission, though framed as a technical inquiry, embodied the broader colonial logic: expertise and authority monopolized by the imperial metropole. For Ambedkar, this exclusion was not just administrative—it was epistemological. He rejected the notion that constitutional design could be shaped by outsiders who, like the Commission, operated from a position of racial and political superiority. In his writings and speeches during this period, he articulated a vision of political agency grounded in experiential knowledge—particularly the lived realities of India's marginalized castes and Dalits. His argument was clear: "No constitutional reform is legitimate unless it is made by Indians, for Indians, with full participation from all strata of society." The economic context of the late 1920s deepened this crisis of legitimacy. India was reeling from the aftermath of the 1925–26 agrarian crises, the collapse of rural economies, and the deepening structural dependence on British mercantile policies. The global Great Depression loomed on the horizon, threatening

to further destabilize India's agrarian base and industrial nascentness. Ambedkar, who had long analyzed India's economic subjugation through a Marxist-influenced lens, saw the Simon Commission not only as a political affront but as a symptom of a failing colonial economy that prioritized imperial extraction over indigenous development. He argued that without inclusive representation, no constitutional framework could address the economic inequities that underpinned social oppression. Ambedkar's intellectual response was both analytical and strategic. His critique extended beyond India's borders: he drew parallels with anti-colonial movements in Africa and the Caribbean, where exclusion from imperial deliberations fueled resistance. The Simon Commission thus became a global node in the broader struggle against racialized governance. The political

impact of Ambedkar's resistance was immediate and far-reaching. His call for a boycott of the Commission galvanized nationalist unity across regional, linguistic, and caste lines. Leaders from the Indian National Congress to regional satyashodhaks and Dalit organizations aligned behind his demand for Indian participation. This unity, though fragile, signaled a shift from elite negotiations to mass-based resistance. Ambedkar's insistence on inclusion also reshaped the discourse of Indian federalism—foreshadowing later debates over center-state dynamics and minority rights. He challenged the very architecture of colonial governance: if legitimacy required consent, then consent could only come through inclusion. Economically, Ambedkar's critique highlighted the incompatibility of colonial rule with sustainable development. He pointed to the skewed tax regimes, land revenue systems designed to maximize extraction, and the lack of investment in indigenous industries—all undercut by a governance model that excluded the very populations whose labor sustained the economy. exposed the bankruptcy of a colonial economic model that denied agency as a prerequisite for stability. From a geopolitical standpoint, the Simon Commission reflected Britain's anxiety over rising anti-colonial nationalism. The early 1920s saw the emergence of transnational movements—from Gandhi's non-cooperation to the spread of socialist ideas across Asia and Africa. Yet Ambedkar's arguments gained traction as the Commission's refusal to include Indians became a symbol of colonial arrogance.
