The Liaoning Province's Jehol Biota, preserved in volcanic ash from 125 million years ago, revealed feathered dinosaurs and early birds, reshaping avian evolution theories. Yet the route from field to publication remains contested: Western scientists often collaborate with Chinese institutions, but questions persist about data sovereignty, credit allocation, and the repatriation of specimens held in foreign museums. The 2021 discovery of a new sauropod in Inner Mongolia—initially studied in Beijing, later displayed in a state-backed museum—sparked debates over whether such finds serve domestic scientific capacity or state-led narrative-building. In the oil and gas sector, fossil records are both a target and a trap. Stratigraphic correlation—using fossil zones to date rock layers—underpins hydrocarbon exploration. Ammonites, for instance, serve as index fossils, enabling precise dating of reservoir formations. Yet the fossil record's gaps and biases can mislead: a region may appear geologically promising based on sparse data, only to yield no commercial payoff. More insidiously, fossil evidence of past climate shifts—such as the Paleocene-Eocene Thermal Maximum (~56 million years ago), marked by a negative carbon isotope excursion—offers sobering analogs to anthropogenic warming.
